

ARTICLES OF INCORPORATION OF

FLORIDA SPICE COMPANY



The undersigned, acting as the incorporator of the Corporation under the Fiorida Business Corporation Act, adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME OF THE CORPORATION
