# ARTICLE IX. RESTRAINT ON ALIENATION OF SHARES

purchase by the professional service corporation in accordance with the bylaws adopted by the shareholders.

The corporation reserves the right to amend or repeal any provisions in these articles of incorporation in the manner provided by law. Any right conferred on the shareholders is subject to this reservation.
