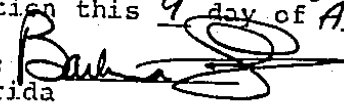

ARTICLE EIGHT.

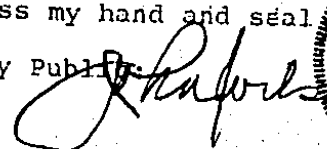

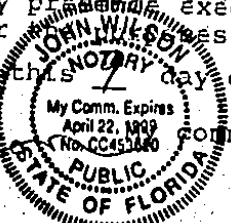

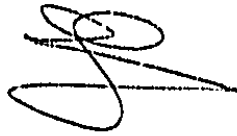
