


The power to adopt, alter and amend or repeal bylaws shall be vested in the Board of



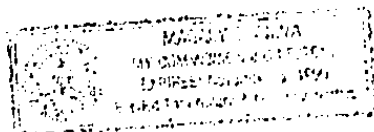
