ARTICLE I - NAME

The name of this Corporation shall be:
The Writing Stable, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing
on 08/15/96.

ARTICLE III - PURPOSE

ARTICLE IX - AMENDMENT




