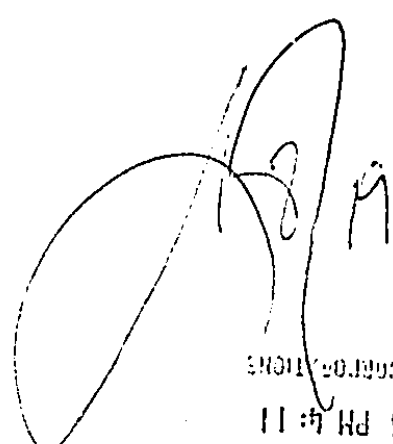

SECTION 1.01 NAME:
