**ARTICLES OF INCORPORATION
OF
INTERNATIONAL FITNESS EQUIPMENT, INC.**

The undersigned incorporation hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I

The name of the Corporation shall be **International Fitness Equipment, Inc.**

ARTICLE II

The principal office of this Corporation shall be located in the City of Plantation, Broward County, Florida and the street address of said principal office shall be, 5560 Cypress Road, Plantation, Florida 33317.

ARTICLE III

This Corporation is organized for the following purposes:

1. To engage in the sales and service of commercial exercise equipment.

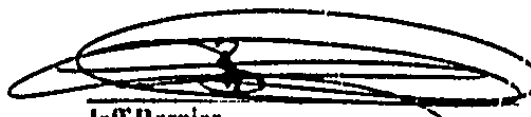
ARTICLE X

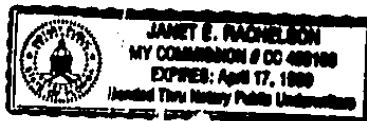
