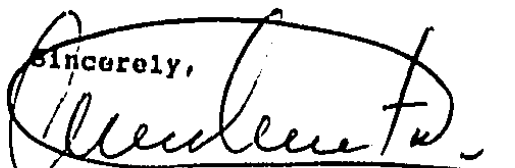

shall be as valid as though it had been authorized at a meeting of the Board of Directors.

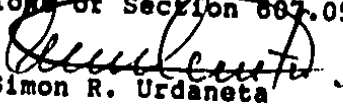

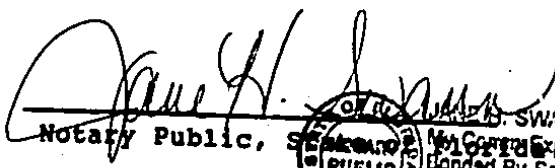

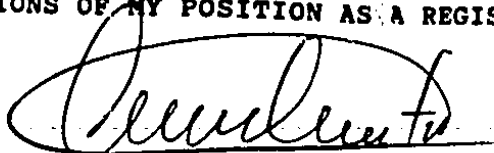
