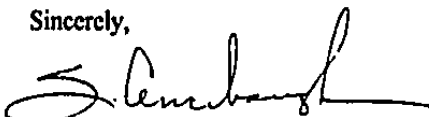

OF  
JT SERVICES, INC.**

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the said State of Florida.

**Article I**

The name of this Corporation shall be **JT Services, Inc.**

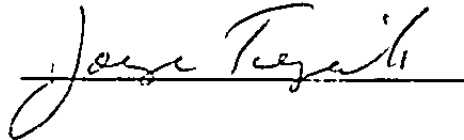

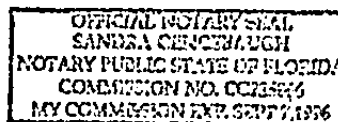

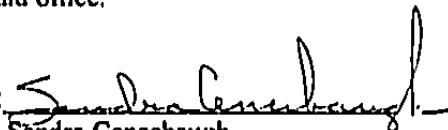
