OF

into a corporation pursuant to the provisions of the Laws of the State of Florida
providing for the formation of corporations for profit, and for the purposes and with the
powers hereinafter mentioned; and, to that end, we do by this Certificate set forth:

ARTICLE I. NAME

That the name of this corporation shall be:

The primary nature of this corporation's business will be to clean carpets.

This corporation may also engage or interact in any or all lawful activities or

ARTICLE VI. TERM OF EXISTENCE

That the term for which this corporation shall exist shall be perpetual.

ARTICLE VII. ADDRESS

That the address of the principal office of the corporation in the State of Florida is:
