ARTICLES OF INCORPORATION

OF

DOLPHIN STORAGE, INC.

ARTICLE I - NAME

The name of this corporation is Dolphin Storage, Inc.

ARTICLE IL - DURATION

This corporation shall exist in perpetuity from the date of the filing of these Articles of Incorporation.

ARTICLE III - PURPOSES
