**ARTICLES OF INCORPORATION  
OF**

**CONSULTATION AND EDUCATION UNLIMITED, INC.**

**THE UNDERSIGNED**, acting hereby as Incorporator for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit, pursuant to Chapter 607, Florida Statutes, and other applicable law, do hereby adopt the following Articles of Incorporation:

**ARTICLE I  
NAME**

The name of the corporation shall be **CONSULTATION AND EDUCATION UNLIMITED, INC.**

**ARTICLE II  
ADDRESS AND REGISTERED OFFICE**

The street address, principal place of business and registered office of this corporation is hereby designated to be 5 Willard Drive, Suite 140, St. Augustine, Florida 32086, and such principal place of business and registered office may be changed in accordance with the By-Laws of the corporation or by appropriate action of the Board of Directors.
