ARTICLES OF INCORPORATION

of

The undersigned, all of lawful age, hereby associate ourselves together for the purposes of becoming a corporation under the laws of Florida.

I.

The name of the corporation shall be: FLORIDA FLOOR CARE, INC.

II.

LAHASSEE, FLORIDA

The purpose of this corporation shall be:
