The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act hereby adopts the following articles of incorporation:

ARTICLE I

Name of Corporation

The name of the corporation is:  
ALL PLUMBING SERVICE OF FLORIDA, INC.

ARTICLE II

Duration of the Corporation

The term of existence of the corporation is perpetual.

ARTICLE III

Purpose of the Corporation

The purpose for which the corporation is organized is to engage in any lawful business or activity for which a corporation may be incorporated under the Florida Business Corporation Act.

ARTICLE IV

Stock of the Corporation
