## ARTICLES OF INCORPORATION OF DOCTORS TOTAL WELLNESS CENTER, INC.

LEE KADOSA, M.D. incorporator, the undersigned, hereby organizes for the purpose of becoming a Corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the said State of Florida, providing for the formation; rights, privileges, immunities, and liabilities of Corporations for profit.

#### ARTICLE 1 - NAME

The name of the Corporation shall be DOCTORS TOTAL WELLNESS CENTER, ING.

## **ARTICLE II - DURATION**

This Corporation shall exist perpetually, commencing on the date of execution and acknowledgement of these Articles.

#### ARTICLE III - PURPOSE

The Corporation may engage in any activity or business under the laws of the United States and the State of Florida's General Corporation Act.
