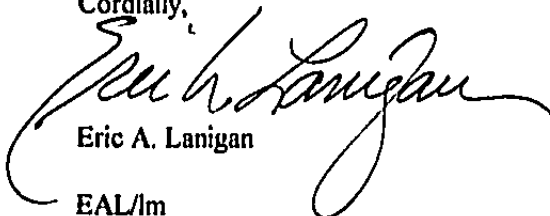

The undersigned acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

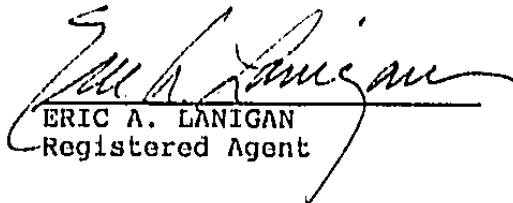
1. NAME. The name of this corporation is VISTA SIGN, INC.

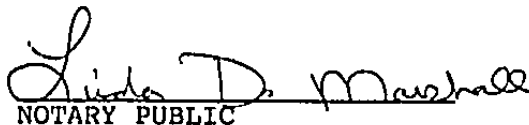
