ARTICLE I - NAME

The name of this corporation is: ALACHUA PROFESSIONAL CENTER OWNERS ASSOCIATION, INC.

ARTICLE II - ADDRESS OF PRINCIPAL OFFICE

The address of the principal office of the corporation is 12805 N.W. 146th Place, Alachua, Florida 32615, and the mailing address of the office of the corporation is Post Office Box 1300, Alachua, Florida 32615.

ARTICLE III - PURPOSE OF CORPORATION

- 1. The purpose of this corporation is to provide for an owners association for the owners of the property in Alachua County, Florida, described in Exhibit A hereto,
- 2.
