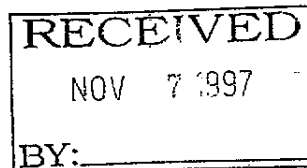

ARTICLES OF INCORPORATION OF

1. Article 1, NAME AND MAILING ADDRESS of the Corporation's Articles of Incorporation is hereby amended in its entirety, so as to read after amendment as follows:

ARTICLE 1
NAME AND MAILING ADDRESS

The name of this Corporation is DESIGNER WINDOW PRODUCTS, INC., and its principal office or mailing address is 5609 70th Avenue North, Pinellas Park, Florida 33781.
