**ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

1. NAME. The name of the Corporation is: **Cintia Cuperman, M.D., P.A.**
2. DURATION. The period of its duration is perpetual.
3. PURPOSE. The purpose is to engage in the practice of medicine permitted under the laws of the United States of America.
