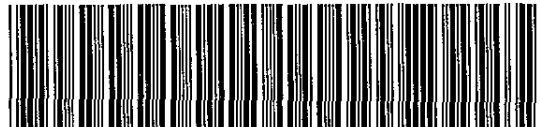



Article III - Approval of Dissolution


The dissolution was approved by all of the shareholders of the Corporation by written consent dated January 9, 2006, pursuant to Section 607.0704 of the Florida Statutes.
