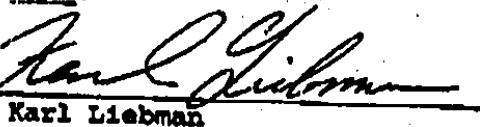
ARTICLE IX

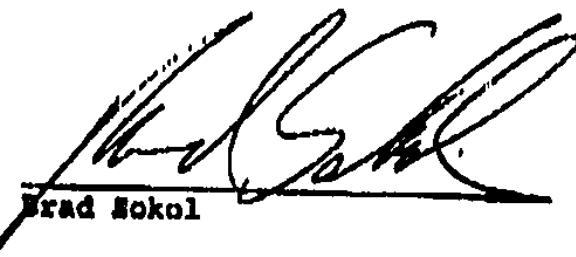
