#### ARTICLE I

#### NAME

The name of the Corporation is THE REALTY FUND, INC., and its mailing address is 102 Lexington Street, Oldsmar, Florida 34677.

### ARTICLE II

## **DURATION**

This corporation shall exist perpetually, commencing as of the date of acceptance and filing of these Articles by the Secretary of State of Florida.

#### ARTICLE VIII

## **CUMULATIVE VOTING**

At each election for directors every shareholder entitled to vote at such election shall have the right to cumulate his votes by giving one candidate as many votes as the number of directors to be elected at that time multiplied by the number of his shares, or by distributing such votes on the same principle among any number of such candidates.

### ARTICLE IX

### PREEMPTIVE RIGHTS
