ARTICLES OF INCORPORATION

OF

The undersigned subscribers to these Articles of The Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation, under the laws of the State of Florida.

ARTICLE I - NAME

ARTICLE II - NATURE

The nature of the business to be transacted by this corporation is: RETAIL SALES OF CHILDRENS CLOTHING AND FURNISHINGS,

To erect dwellings, apartment houses and other buildings, private or public, of all kinds, and to sell or rent the same. To lay out, grade, pave and dedicate roads, streets, avenues, highways, alleys, courts, paths, walks, parks, cemeteries and playgrounds.
