ARTICLE I

NAME

The name of this corporation is:

ARTICLE II

NATURE OF CORPORATE BUSINESS

1. This Corporation may engage in any activity or business permitted under the laws of the United States of America and the State of Florida.

1. CAPITAL STOCK

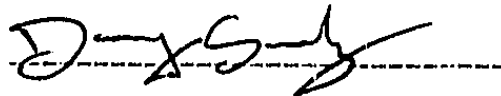
