The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby organises and incorporates a corporation under the laws of the State of Florida.

ARTICLE I. MANOR

The name of the corporation is CONTINUENTAL CIRCUS INC.

ARTICLE II. MATURE OF BUSINESS

This corporation may engage in the transaction of any or all lawful husiness permitted under the laws of the United States and the Florida General Corporation Act.

ARTICLE III. CAPITAL STOCK
