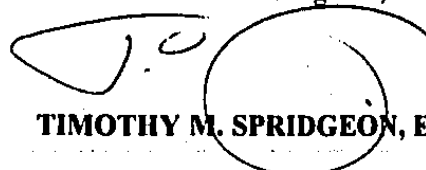

ARTICLE I - NAME

The name of the Corporation is Entrepreneurs 'R' Us, Inc. The address of the principal office for the Corporation is 3153 Lake Pine Way, Bldg. 229-62, Tarpon Springs, Florida 34689.

ARTICLE II - DURATION

The Corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the Florida Secretary of State.

ARTICLE III - PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under Chapter 607 of the Florida Statutes.

ARTICLE IV - CAPITAL STOCK

The Corporation is authorized to issue 7,500 shares of capital stock of the par value of One Dollar (\$1.00) which shall be designated "Common Shares," and all of which shall have the same rights and privileges.

ARTICLE V - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of the Corporation, of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rate share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the Corporation is 315 East Madison Street, Suite 1000, Tampa, Florida 33602, and the name of the initial registered agent of the Corporation at that address is Timothy M. Spridgeon, Esquire.

ARTICLES VII - INITIAL BOARD OF DIRECTORS

ARTICLE XI - AMENDMENT

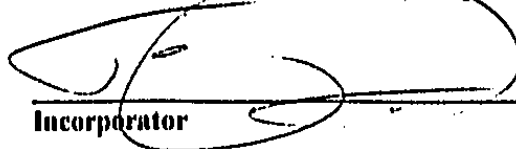
