# ARTICLES OF INCORPORATION

OF

### OVER 50 & LOVING IT CORP.

### ARTICLE I - NAME

The name of the Corporation is Over 50 & Loving It Corp. The address of the principal office for the Corporation is 3153 Lake Pine Way, Bldg. 229-62, Tarpon Springs, Florida 34689.

## **ARTICLE II - DURATION**

The Corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the Florida Secretary of State.

# **ARTICLE III - PURPOSE**
