ARTICLES OF INCORPORATION OF WORKAHOLICS BETA, INC.

(for profit corporation)

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE | NAME

The name of the corporation shall be: WORKAHOLICS BETA, INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 802 North Beicher Road, Clearwater, Florida 34625.

ARTICLE III DURATION

The duration of the corporation is perpetual.

ARTICLE IV PREEMPTIVE RIGHTS

A director shall not be liable for dividends lilegally declared, distributions lilegally made to shareholders, or any other action taken in reliance and in good faith upon financial statements of the Corporation represented to him to be correct by the President of the Corporation or the officer having charge of the books of account, or certified by an independent or certified accountant to clearly reflect the financial condition of the Corporation; nor shall he be liable if in good faith in determining the amount available for dividends or distribution, he considered the assets to be of ample value.
