ARTICLES OF INCORPORATION OF

HOTSPOTS ENTERTAINMENT GROUP, INC.

Article 1

Name. The name of this Corporation is HotSpots Entertainment Group, Inc.

Article II

Principal Office. The address of the principal office of the Corporation is 2220 SW 34th Street, #100, Gainesville, Florida 32608.

Article III

Duration. The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles.

Article IV

Purpose. The purpose of this Corporation is to engage in any activities or businesses permitted under the laws of the United States and under the Florida General Corporation Act including, but not limiting the acquisition of life insurance bonds, debentures, commodities, leaseholds, options, puts and calls, casements, mortgages, notes, mutual funds, investment trusts, common trust funds, voting trust certificates, and any class of stock or right to subscribe for stock, including trading on margin.
