That we, STEVEN A. WEST, MICHAEL WEST and ALLAN SCOTT ASHBROOK, the undersigned, have this day voluntarily associated ourselves for the purpose of forming a corporation under the laws of the State of Florida, and to that end do hereby adopt Articles of Incorporation as follows:

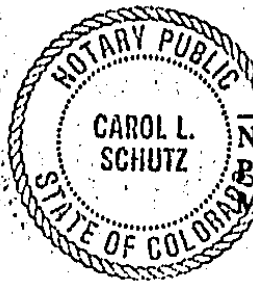
