**ARTICLES OF INCORPORATION
OF

The undersigned hereby associate for the purpose of becoming a corporation for profit under the laws of the State of Florida in compliance with Florida Statute §607.0202.

Article I

The name of the corporation shall be Jacob Consulting Group, Inc.

Article II

The mailing address of the principal office of the corporation shall be:

Article III

The corporation is being formed and the general nature of the corporation's business shall be marketing and real estate consulting, as well as to engage in any other activity or business permitted under the laws of the State of Florida.

Article IV

The amount of capital stock of the corporation shall be Five Hundred (500) shares of common stock with no par value.

Article V

The amount of capital with which the corporation will begin business will be no less than \$500.00.

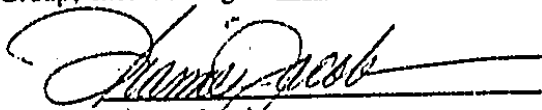

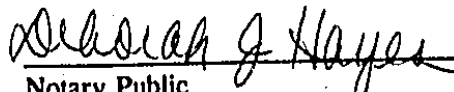

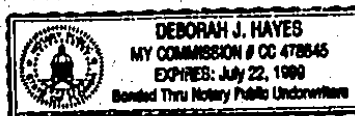
