The undersigned, acting as a incorporator of a Florida corporation under the Professional Service Corporation Act, Chapter 621 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

#### **ARTICLE 1**

#### NAME

#### **ARTICLE II**

#### **DURATION**

The Corporation shall have perpetual existence.

#### **ARTICLE III**
