The undersigned, for the purpose of amending Articles of Incorporation under the Florida General Corporation Act, do hereby adopt the following amendments to the Articles of Incorporation.

ARTICLE I - NAME

Article I is hereby amended by deleting the existing language and inserting the following: The name of the corporation is TRUCKS AND CARS FOR YOU, INC.

The amendment is adopted effective October 15, 1998.
