## ARTICLES OF INCORPORATION

The undersigned natural person of the age of twenty-one (21) years or more, acting as incorporator of a corporation under the Florida Business Corporation Act, does hereby adopt the following Article of Incorporation.

## ARTICLE I - MAME

The name of this Corporation is Tyre Benefit & Investment Services, Inc. (hereinafter called the "Corporation").

## ARTICLE II - EFFECTIVE DATE AND DURATION

The Corporation will have an effective date of August 16, 1996 and will exist for a perpetual period.

#### ARTICLE III - PURPOSE

The purpose for which the Corporation is organized is to engage in any lawful business or activity permitted under the laws of the State of Florida.

#### ARTICLE IV - CAPITAL STOCK

The Corporation is authorized to issue one thousand (1,000) shares of common stock, having a par value of one cent (\$0.01) per share.

#### ARTICLE V - INITIAL REGISTERED AGENT AND OFFICE
