**ARTICLES OF INCORPORATION OF  
HAJELA AND PATEL ENTERPRISE, INC.**

The undersigneds, acting as incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

1. **NAME.** The name of this corporation is HAJELA AND PATEL ENTERPRISE, INC.

2. **DURATION.** The period of its duration is perpetual.

3. **PURPOSE.** The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States and the State of Florida.

4. **CAPITAL STOCK.** The corporation is authorized to issue 100 shares of stock, all of one class, at \$1 par value.

5. **INITIAL REGISTERED AGENT AND PRINCIPAL OFFICE.** The name and address of the initial registered agent is:

7. **INCORPORATORS.** The name and address of the Incorporators signing these Articles of Incorporation are SHIKHA HAJELA and SANDIP C. PATEL.

8. **AMENDMENT OF ARTICLES.** This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

9. **PRE-EMPTIVE RIGHTS.** Each shareholder of this corporation shall have the first right to purchase shares (and securities convertible into shares) of any class, kind or series of stock in this corporation that may from time to time be issued (whether or not presently authorized), including shares from the treasury of this corporation, in the ratio that the number of shares he or she holds at the time of issue bears to the total number of shares outstanding, exclusive of treasury shares. This right shall be deemed waived by any Shareholder who does not exercise it and pay for the shares or other securities preempted within ninety (90) days of receipt of a notice in writing from the corporation, stating the prices, terms and conditions of the issue of shares, and inviting them to exercise their pre-emptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within ninety (90) days of receipt of notice from the corporation.

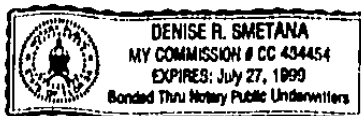
