#### ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of incorporation.

#### ARTICLE\_I

The name of this corporation shall be SERENOA, Inc.

#### ARTICLE II

The existence of this corporation shall be perpetual.

# ARTICLE III
