

ARTICLES OF INCORPORATION OF PEPE'S MARKET, INC.



The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE 1 -- Name

The name of this corporation is PEPE'S MARKET, INC.

ARTICLE II --- Commencement and Duration (Delayed Effective Date)

The corporation is to commence its corporate existence ten (10) days after the date of subscription and acknowledgment of these articles of incorporation by Joseph Mendez, and shall exist perpetually thereafter until dissolved according to law.

ARTICLE III - Purpose

The corporation is organized for the purpose of transacting any and all lawful business, and it is specifically contemplated by the parties hereto that the primary initial purpose of said corporation will be a market.

ARTICLE IV -- ADDRESS

ARTICLE VI -- Stated Capital

The maximum number of shares that this corporation is authorized to have outstanding at any one time is five hundred (500) shares of common stock having a par value of \$1.00 per share.

Each outstanding share, regardless of class, shall be entitled to one vote on each matter submitted to a vote at a meeting of the shareholders.

The shares of stock may be issued for such consideration, having a value not less than the par value of the shares issued therefor, as is determined from time to time by the board of directors, to be paid, in whole or in part, in cash or other property, tangible or intangible, or in labor or services actually performed for the corporation. Shares may not be issued until the full amount of the consideration therefor has been paid. Thereafter, such shares shall be deemed to be fully paid and nonassessable.

ARTICLE VII -- Board of Directors

All corporate powers shall be exercised by and under the authority of, and the business and affairs of the corporation shall be managed under the direction of, the board of directors.

Any and all of the powers and duties conferred to or imposed upon the board of directors by resolution of the shareholders adopted at a special meeting called for that purpose, may be exercised or performed to such extent and by such person or persons as shall be provided by the shareholders.

The corporation shall have one director initially, who shall be **JOSEPH MENDEZ**. The number of directors may thereafter be increased or decreased from time to time in accordance with the bylaws of the corporation. Cumulative voting shall be permitted by the bylaws. ARTICLE VIII - Indemnification

The corporation shall indemnify any present or former officer or director, or person exercising powers and duties of a director, to the full extent now or hereafter permitted by law.

ARTICLE IX --- Bylaws

The power to adopt, alter, amend or repeal bylaws shall be vested in the board of directors and the shareholders, but the board of directors may not alter, amend or repeal any bylaws adopted by the shareholders.

X -- RESTRAINT ON ALIENATION OF SHARES

The bylaws of the corporation shall provide for the restraint on alienation of shares so that any shareholder who desires to sell, pledge, give away or otherwise dispose of his or her shares must first offer the shares to the other shareholders in proportion to their then existing holdings at a price to be determined by the directors or shareholders.

Furthermore, such bylaws shall contain the following provisions:

A. DECEASED SHAREHOLDERS

A provision shall be included to restrict alienation of shares of a deceased shareholder.

The provision shall indicate that upon death of a shareholder the remaining shareholders shall have the same right to purchase, within a predetermined number of days of the death of said shareholder, the shares of the deceased shareholder as though an offer to soil had been made to them as in the case of a voluntary offer of sale.

B. PREEMPTIVE RIGHTS OF EXISTING SHAREHOLDERS

Existing shareholders shall have preemptive right to purchase any newly issued stock in proportion to the ownership of the stock on the date of creation of the newly issued stock.

ARTICLE XI -- Amendment

These articles of incorporation may be amended at any time by a vote of the majority of the voting stock of the corporation outstanding, at any regular meeting of the stockholders, or at any special meeting of the stockholders called for that purpose.
