The undersigned subscriber to these Articles of Incorporation, each a natural person, competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida, Florida Statutes 607.001 ot. neg., and the corporation so formed shall be for profit.

### ARTICLE I - NAME, OFFICE & MAILING ADDRESS

The name of the corporation shall be: NEWS EXPRESS, INC., located at 732 N.W, 76TH AVENUE, MIAMI, FLORIDA 33126.

# ARTICLE II - TERM OF EXISTENCE

This corporation is to exist perpetually and shall commence at the time of filing these Articles.

### ARTICLE III - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be the purchase, sale and distribution of tangible personal property within and without the United States; as well as any other business now or in the future lawful in the State of Florida or any other jurisdiction where the corporation transacts business.
