ARTICLES OF INCORPORATION

19-19 CP

ARTICLE I Corporate Name

The name of the corporation is National Medical Recruiting & Consulting, Inc.

ARTICLE II Corporate Purpose

The purpose or purposes for which the corporation is organized is to congage in any activity within the purposes for which corporations may be organized under the Laws of the State of Florida, in particular, but not by way of limitation, to engage in the business of mational placement of physicians and to own real estate or securities or both for the purpose of investment, and to engage in operations and to acquire, operate and dispose of both real and personal property incident to the corporation's primary purpose.

ARTICLE III Stated Capital
