**ARTICLE I - NAME**

The name of the corporation T.C. DISTRIBUTIONS, CORP., located at 3977 Southwest 143 Place, Miami, Florida 33175.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence.

**ARTICLE III - PURPOSE**

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation in accordance with the provisions of the Florida General Corporation Act.

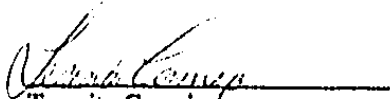
