ARTICLES OF INCORPORATION OF JOHN LUMSDEN, INC.

The undersigned hereby makes, subscribes, acknowledges and files these Articles of Incorporation for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE 1

NAME

The name of the Corporation shall be JOHN LUMSDEN, INC.

ARTICLE II

CORPORATE DOMICILE

The principal corporate domicile shall be 11786 Timbers Way, Boca Raton, FL 33428

ARTICLE III

NATURE OF BUSINESS

The Corporation is organized for the purposes of engaging in any activity or business permitted under the laws of the United States or of this State, more specifically set out as follows:

- 1. To do all such activities and engage in all such transactions as are necessary to a manufacturing, resale, and service business.
- 2. To transact any lawful business for which Corporations may be incorporated under the Florida General Corporations Act or engage in any other of business which can, in the opinion of the Board of Directors of the Corporation, be advantageously carried on in connection with the foregoing business.
- 3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
