# ARTICLES OF INCORPORATION OF JITTERS JAVA HOUSE, INC.

#### ARTICLE I. NAME

The name of this corporation shall be JITTERS JAVA HOUSE, INC.

## ARTICLE II. COMMENCEMENT & DURATION
