ARTICLES OF INCORPORATION

OF

GRIFFIN & GRIFFIN INVESTMENTS, INC

PALLED STATES The undersigned, for the purpose of forming a corporation under the laws of the State of Florida under the corporate name of GRIFFIN & GRIFFIN INVESTMENTS, INC. does hereby set forth and declare:

CHAR ER

ARTA Æ I

The name of the corporation shall be, GR FFIN & GRIFFIN INVESTMENTS, INC., Community of Immokalee, County of Collier, Sure of Florida.

ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III

The authorized capital stock which the corporation may issue shall be One Thousand (1000) shares of \$1.00 par value common stock, which shall be nonassessable and held, sold, and paid for at such time and in such manner as the Board of Directors may from time to time determine.

ARTICLE IV


