

## ARTICLES OF INCORPORATION OF TWIN CREEKS CORPORATION

The undersigned, acting as incorporator of the captioned corporation under the Florida

Business Corporation Act, adopts the following Articles of Incorporation:

EFFECTIVE DATE

#### ARTICLE I

#### Corporate Name and Principal Office

The name of this corporation is Twin Creeks Corporation and its principal office and street address is 5216 Twin Creeks Drive, Valrico, Florida 33595; its mailing address is Post Office Box 430, Valrico, Florida 33595.

#### **ARTICLE II**

#### Commencement of Corporate Existence

The corporation shall come into existence on August 21, 1996.

#### **ARTICLE III**

#### General Nature of Business

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.

#### **ARTICLE LY**

#### Capital Stock
