ARTICLES OF INCORPORATION

of

## NORTH FLORIDA JANITORIAL/NU-STEAM, INC. a Florida corporation

I, the undersigned subscriber to these Articles of Incorporation, natural person competent to contract, hereby form a corporation under the laws of the State of Florida pursuant to the provisions of the applicable Florida Statutes:

#### ARTICLE 1 - CORPORATE NAME

The name of this Corporation shall be NORTH FLORIDA JANITORIAL/NU-STEAM, INC., a Florida corporation.

#### ARTICLE II - NATURE OF CORPORATE BUSINESS

This corporation, through its officers and employees, shall be authorized to sell and provide jamitorial and cleaning services, both residential and commercial, buy, sell, lease, own, rent, market, mortgage, transfer, quit-claim, and convey real and personal property; and participate in all other activities which may be necessary to the operation of such business.
