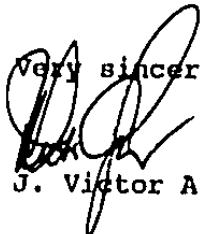

ARTICLES OF INCORPORATION
of
NORTH FLORIDA JANITORIAL/NU-STEAM, INC.
a Florida corporation

I, the undersigned subscriber to these Articles of Incorporation, natural person competent to contract, hereby form a corporation under the laws of the State of Florida pursuant to the provisions of the applicable Florida Statutes:

ARTICLE I - CORPORATE NAME

The name of this Corporation shall be NORTH FLORIDA JANITORIAL/NU-STEAM, INC., a Florida corporation.

ARTICLE II - NATURE OF CORPORATE BUSINESS

This corporation, through its officers and employees, shall be authorized to sell and provide janitorial and cleaning services, both residential and commercial, buy, sell, lease, own, rent, market, mortgage, transfer, quit-claim, and convey real and personal property; and participate in all other activities which may be necessary to the operation of such business.

ARTICLE III - CAPITAL STOCK

This corporation shall be authorized to have a maximum of 100 shares of stock outstanding at one time. The shares of stock authorized shall be common stock having a par value of One Dollar (\$1.00) per share. The consideration to be paid for each share of stock shall be fixed by the Board of Directors.

ARTICLE IV - INITIAL CAPITAL

The amount of capital with which this corporation shall begin business shall be no less than One Hundred Dollars (\$100.00).

ARTICLE V - TERM OF EXISTENCE

This corporation shall have a perpetual existence.

ARTICLE VI - POST OFFICE ADDRESS

This corporation shall have no less than one (1), nor more than three (3) directors. The number of directors may be altered from time to time by By-Laws adopted by shareholders.

ARTICLE XI - AMENDMENT

These Articles of Incorporation may be amended in the manner provided in the Florida Statutes, or any successor provision in said Statutes. Every amendment shall be approved by the Board of Directors, proposed by them to the Stockholders, and approved at a Stockholder's Meeting by a majority of the stock entitled to vote thereon. However, in lieu of the above-described procedure, an amendment may be made by a written instrument signed by all of the Directors and Stockholders of this Corporation.

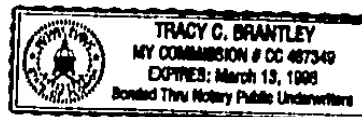
