The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves to form a s-corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of this s-corporation is:

**VECTOR HEALTHCARE CONSULTANTS, INC.**

ARTICLE II

NATURE OF BUSINESS

The general nature of the business and the objects and purposes to be transacted and carried on are:

To conduct a medical billing and consulting business and in addition to conduct any and all lawful business for s-corporations which may be incorporated under the laws of the State of Florida.

And, in general, to carry on any other business whatsoever in connection with the foregoing or which is calculated, directly or indirectly, to promote the interest of the s-corporation or to enhance the value of its properties.

And further, to borrow or raise money for any purposes of the company, and to secure the same interest, or for other purposes, to mortgage all or any part of the property corporeal, rights of franchises of this company now owned or hereinafter acquired, and to create, issue, draw and accept and negotiate bonds and mortgages, bills of exchange, promissory notes or other obligations or negotiable instruments.
