# ARTICLES OF INCORPORATION (Professional Corporation)

of

## SANTA ROSA DE LIMA MEDICAL, P.A.

The undersigned, who is duly licensed to practice medicine in the State of Florida, desiring to form a professional corporation in accordance with Chapter 607 of the Florida Statutes and the Florida Professional Service Corporation Act, adopts the following Articles of Incorporation:

### L NAME

The name of the corporation shall be SANTA ROSA DE LIMA MEDICAL, P.A.

#### II. PURPOSE

The purpose for which the corporation is organized is to practice the profession of medicine.

#### III. DURATION

The term of existence of the corporation is perpetual.

#### IV. CAPITAL STOCK

The number of shares of stock that the corporation is authorized to have outstanding is 100 shares, all of which shall be common shares with par value of \$100.00 per share.

#### V. CAPITAL
