OF

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

### ARTICLE I.

The name of the corporation shall be WINTER PARK DELIGHTS, INC.

### ARTICLE II. ADDRESS - REGISTERED AGENT

# ARTICLE III. NATURE OF BUSINESS
