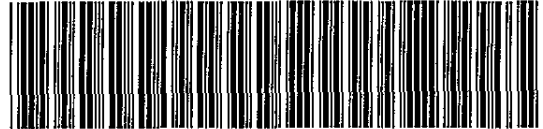



1. ARTICLE I of the Articles of Incorporation of is hereby amended to read as follows:



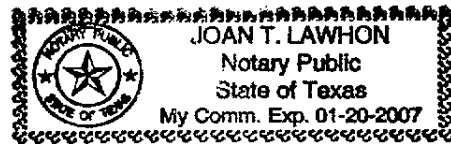
